► Course Objectives:

The aims of the course are as follows:

2. To examine the impact of risk on the decision-making processes of organizations.
3. To review the techniques used to identify, categorize and measure these risks.
4. To examine strategies and techniques used to mitigate the impact of these risks on the business, including the role of strategy formulation and implementation and the development of effective risk control strategies, processes and structures.
5. To understand the compliance requirements of the organization and to examine practical ways of ensuring these requirements are met.

This course will enable participants to gain a better understanding of the significance of adequately assessing and managing risk in the context of the management of business operations and in making informed business decisions. It will also enable participants to implement processes to understand and meet compliance requirements of the organization.
